

BY-LAW NO. 92-5

*A By-Law to alter the boundaries of wards and ward representation of the Turtle Mountain School Division No. 44.*

*Whereas the Board of Reference award dated December 17, 1991 directed the Division to reduce the number of trustees in Ward IV from three to two and to increase the number of trustees in Ward II from three to four and that this adjustment to elected representation be undertaken by the Turtle Mountain School Division No. 44 as expediently as possible and in accordance with sections 57 (1) (c) and 57 (g) of the Public Schools Act;*

*and*

*Whereas the Board of Reference award dated August 20, 1992 has altered the school division boundaries and reduced the number of trustees from 11 to nine (9) ;*

*and*

*Whereas it is deemed advisable to alter the boundaries of the wards to encompass the remainder of land in the former Ward III which was not transferred out of the school division under the August 20, 1992 Board of Reference award;*

*and*

*Whereas by-law 7-1971 currently in effect for ward boundaries and trustee representation is not consistent with the directives from the Board of Reference in the December 17, 1991 and August 20, 1992 awards.*

*Now therefore we do enact as follows:*

- 1. That the present ward boundaries be rescinded from the effective date of this by-law.*
- 2. That the Wards and representation within the wards of the Turtle Mountain School Division No. 44 be as herein listed:*

*(a) Ward I:*

*Ward I to include the Town of Boissevain, all of that portion of Rural Municipality of Morton within the Division; plus sections 5, 6, 7, 8, 17, 18, 19, 20, 29, 30, 31, 32 - Township 3, Range 18, within the Rural Municipality of Turtle Mountain; and the Turtle Mountain Forest Reserve.*

*Representation of Ward I is set at three (3) trustees.*

*(b) Ward II:*

*Ward II to include the Town of Killarney and all of the Rural Municipality of Turtle Mountain excepting sections 5, 6, 7, 8, 17, 18, 19, 20, 29, 30, 31, 32 - Township 3, Range 18 plus all that portion of the Rural Municipality of Roblin within the Division plus all of the Rural Municipality of Strathcona within the Division lying south of the North Boundary of Township four (4), plus all the portion of the Rural Municipality of Argyle within the Division.*

*Representation of Ward II is set at four (4) trustees.*

*(c) Ward III (formerly Ward IV):*

*Ward III to include all of that portion of the Rural Municipality of Whitewater within the Division, all of that portion of the Rural municipality of Riverside within the Division and all of that portion of the Rural Municipality of Strathcona within the Division lying North of the North boundary of Township four (4).*


*Representation of Ward III is set at two (2) trustees.*

- 3. That the ward boundaries set out in this by-law take effect as at on and from the 31st day of August A.D., 1992.*
- 4. That the trustee representation set out in this by-law take effect as at on and from the 28th day of October, A.D. 1992.*
