TURTLE MOUNTAIN SCHOOL DIVISION NO. 44

BY-LAW 93-3

BEING a By-Law of the Turtle Mountain School Division No. 44 fixing the amount of indemnities and other expenses for Trustees.

WHEREAS Section 56(1) of the Public Schools Act provides in part that a school board may, by bylaw, provide for the payment of an annual indemnity to the chairman and to each trustee payable in such amount at such times and under such conditions as the Board determines:

- (a) Such amounts for each kilometer traveled to and from Board meetings from his/her place of residence to the Division Board Office.
- (b) Such amounts for each hour actually spent under authority previously given by resolution of the School Board in the performance of such duties, work or services as required.
- (c) Such amounts per kilometer, for each kilometer traveled in performance on such duties work or services.

NOW THEREFORE, the Board of Trustees of the Turtle Mountain School Division No. 44 enacts as follows:

- (1) That all previous by-laws fixing indemnities and expenses are hereby revoked.
- (2) That the chairman be paid an annual indemnity of \$1,940.00 to be paid monthly.
- (3) That the Vice-Chairmen and Committee Chairmen be paid an annual indemnity of \$1,615.00 to be paid monthly.
- (4) That each other Trustee be paid an annual indemnity of \$1,290.00 to be paid monthly.
- (5) That each Trustee receive an amount of \$32.50 for each regular and special; Board meeting actually attended.
- (6) That each Trustee, subject to authorization by motion of the Board, be paid an amount of 26.6¢ per kilometer for each kilometer traveled in e performance of Division duties, works or services.
- (7) That each Trustee of the Board be paid 26.6¢ per kilometer for each kilometer traveled to and from the meetings of Trustees from his/her place of residence within the Division.
- (8) That the hourly wage for the per diem be \$10.75 to a maximum of \$80.63.
- (9) That the maximum meal allowances be limited to \$40.55 daily and when necessary the allowance be allocated as: Breakfast \$8.00; Lunch \$9.00; Dinner \$23.55.
- (10) That this by-law become effective the first day of July, 1993.
